2007-08 Independent Verification Worksheet

Your application was selected for review in a process called "Verification". What you should do - Complete this worksheet, attach signed copies of yours (and your spouse's) 2006 Federal income tax returns, sign this form and submit all documents to Western's financial aid office. **Your documentation must be received in our office at least 30 days prior to your last date of enrollment for the 2007-08 school year (June 28, 2007-June 25, 2008).**
