# **Message from the SPAA Director**



equality." The School is making significant and deliberate strides in its relentless pursuit of the mission through high quality innovative educational programs, ongoing scholarly and applied research, and effective engagement in community outreach and service.

Every passage of time presents newfound challenges in the way we carry out our mission of education, research, and service. Staying current, relevant, and impactful offers a value to our students, alumni, and the larger community and yet also challenges and boosts energy to do better in all we do with an eye on our reputation and collective future. The impact that the School can make depends on the ability of our students and alumni in addressing emerging challenges and making a positive impact in their organization, sector, state, country, or even globally. For sure, the newfound challenges we face are real and problems highly complex and multifaceted. It is important to work collaboratively and apply a multidisciplinary lens that our students and faculty are accustomed to in addressing those challenges. Working with diverse stakeholders is a must, as they offer valuable ideas, nuanced insights, and critical perspectives sorely needed to make effective decisions.

This is especially important given the increasingly bifurcated world where ideas and understanding find selective applications. At a time when the trust in government is limited, how public service professionals carry out their duties and responsibilities garners a constant scrutiny. Data from the Pew Research Center show that trust in the United States federal government has declined ever since the turn of the millennium, with its unfavorable view far truncating the favorable view to less than 1/3<sup>rd</sup> over time (see the figures).

# **Message from the SPAA Director (continued)**

There does not also seem to be any encouraging trend or brighter spot other than the fact the state and especially local governments are viewed more favorably, actually by two to one. But even this positive view is worsening lately as the divisiveness is growing rampant, with an engrained partisanship ruling the day.

What can be the take away from observations like this for academics, researchers, and public service professionals? It is the ability to recognize these societal undercurrents while trying to understand the challenges and design and deliver policies and programs that shape our collective future. Functioning with a mantra of transparency, efficiency, effectiveness, and inclusiveness is the need of the hour for public service professionals. After all is said and done, what matters is our ability to work with and support each other, secure our collective destiny, and leave the planet as we inherited, if not in a better shape, to the future generations. The current and future public service students can count on the core competencies of our NASPAA-accredited program that require students to be well versed on communicating and interacting productively with a changing workforce and citizenry. I also hope the mission of the School focused on creating and supporting the societies of respect, liberty, justice, and equality inspires us all in moving forward collectively.

With this general observation, I am pleased to share with you this year's SPAA newsletter, *Public SPAAce*. As always, it reports on some important updates, activities, achievements, recognitions, and much more from the SPAA community. As will be clear throughout this newsletter, the School continues to reinvent and stay current, relevant, and impactful. The School's faculty and

students have been active in scholarly and applied research and service projects. Community engagement remains strong through the SPAA Public Service Engagement Series, course-specific guest speakers, and Advisory Council. The 100% online option for the MPA degree and Accelerated Graduate Degree Program (AGDP) option for students in the Public and Nonprofit Administration major are now fully effective. While the MPA program has experienced a significant enrollment decline—a trend common among similar professional degree programs nationwide—the enrollment is picking up in the new BSPNA program. During the last year, the MPA program admitted 24 students and graduated 14, with the count of active students (admitted and/or taking courses within the last year) at 54. The relatively new BSPNA program has 31 students signed up for the major with two additional students graduating during the year. The undergraduate minors in Public Administration and Nonprofit Administration have 21 students actively taking their courses.

This year we welcomed Dr. Chris Surfus as our newest faculty and said farewell to Dr. Gene McKay after six years of his dedicated and exemplary service.

Please check out this newsletter to find out more. I also welcome your ideas, observations, and suggestions for further improvement in what we do and how we can make impacts, collectively.

# 2022 SPAA Outstanding Alumni Award

Congratulations to Angela Bennett for receiving the 2022 Outstanding Alumni Award from the School of Public Affairs and Administration! This award was presented together with the College level Alumni Achievement

Award at a special ceremony organized by the College of Arts and Sciences to recognize 14 other departmental recipients at Miller Auditorium on October 14, 2022.

Bennett earned her Bachelor's degree in 1994 and Master's degree in 1996 from Western Michigan University, both in public administration with an emphasis on finance and human resources. Her career began with an internship with the City of Kalamazoo while she was in the MPA program, which eventually led to an accomplished public service career at local governments in Michigan.

Appointed as Comptroller in 1999, Bennett oversaw the City of Kalamazoo's accounting and budget operations and took part in initiatives to address the challenges of declining resources precipitated by the 2001 recession. Her move to the City of Lansing as its Budget Manager in 2005 tested her abilities to spearhead a team to weather the financial tsunami in local governance caused by the Great Recession of 2008. Whereas cities must balance their budgets annually, Bennett participated in operationalizing a five-year, \$60 million budget restructuring consisting of service consolidation,



intergovernmental agreements, and compensation restructuring. Later appointed as Deputy Finance Director and then Finance Director in 2012, Bennett is proud of her long tenure at the City, which saw not just a balanced budget but also a general fund balance of \$12 million by the time she left in 2019.

After successfully navigating the unique city council/ mayoral political dynamics for over two decades, Bennett has now joined the Michigan Supreme Court as a Financial Analyst.

Bennett has been active at many professional organizations including the Government Finance Officers Association (GFOA - nationally and in Michigan), Lansing Entertainment and Public Facilities Authority, Michigan State University Extension Program, Habitat for Humanity, and St. Stephen Lutheran Church. She has received the GFOA Financial Reporting Achievement Award twice, once while at the City of Kalamazoo and second while at the City of Lansing.

Bennett is a lifelong public servant modeling the SPAA's core values including common good, democratic governance, ethical leadership, and advocacy for social justice. She is willing to share fond memories of her engagement with career

professionals, elected leaders, and the general public about the way to improve the quality and reach of public services in the two cities. A colleague of hers notes: "She has new and innovative ideas that have been incorporated into new policies and procedures [saving] time and [making] processes more efficient."

Angela is an outstanding public servant who has paid and continues to pay her dues in improving the way local governments are managed and deliver public service with transparency, accountability, effectiveness, efficiency, and social equity. Congratulations to Angela once again for representing the SPAA community so well and making an impact in cities and organizations across Michigan as well as the profession of public affairs and administration!



# **Academic Programs Update**

# **Undergraduate Program**

The new BSPNA program continues to grow, with over 31 current majors and dozens more minors. Students bring a variety of minors and second majors to the program, from marketing and fine arts to global and international studies. We have been expanding our online offerings for the program as well, with PADM 2000 (Introduction to Public and Nonprofit Service) and PADM 3000 (Foundations of Nonprofit Management) now available as asynchronous online courses. We are also expanding the course offerings by developing a new course on Civic **Engagement and Digital Governance** (pending curriculum approval) which will be accessible to students as a part of the Western Essential Studies across all majors and departments. Students can complete a minor in public or nonprofit administration in as little as a year, and requirements for the BS in Public and Nonprofit Administration can be completed in as little as two years.

## **Graduate Programs**

On the Graduate side of SPAA programs, there have been two exciting "things" in the works for several years that are now coming to fruition. The first is an Accelerated Graduate Degree Program (AGDP) and the second is a Graduate Certificate in Tribal Governance.

## **Accelerated Graduate Degree Program**

The Accelerated Graduate Degree Program (AGDP) option within the MPA program is now in the Graduate Catalog. This option is designed for students pursuing the undergraduate major in Public and Nonprofit Administration allowing them to continue onto their graduate studies and receive the 39-credit MPA degree in as little as 27 credits (lower for those with professional experience). This can save students time and money! The AGDP option targets undergraduate students with strong records (3.5+ GPA) to apply in their junior or senior year and take up to six credit hours of 5000- or 6000-level courses in their senior year. They can also apply up to six credit hours from the undergraduate major toward the MPA degree directly. Thus, with good planning, an undergraduate student can earn the MPA degree within one to two years. We are hopeful this will streamline the experience for many students in the coming years. Please contact either Dr. Vickie Edwards or Dr. Matthew Mingus for further information and remember that you must apply for and get accepted into the MPA program and get an approval in advance for the courses you take.

#### **Tribal Governance Graduate Certificate**

WMU has been working for many years with three tribal governments in southwest Michigan to advance the educational needs of their members and employees. In 2019, the WMU Board of Trustees adopted the following statement: "We recognize Western Michigan University is located on lands historically occupied by the Ojibwe, Odawa, and Potawatomi nations. Please take a moment to acknowledge and honor this ancestral land of the Three Fires Confederacy and their continued presence." Years later, the first curriculum development from this ongoing collaboration has emerged from the School of Public Affairs and Administration - the Graduate Certificate in Tribal Governance.

This 12-credit hour certificate program is moving through the final stages of the curriculum development process and will hopefully be in the Fall 2023 Graduate Catalog. The first course was offered in Spring 2022 with the second planned for Spring 2023.

In addition to being a stand-alone certificate, current MPA students will also benefit from the three newly developed tribal governance courses as possible electives (please consult your advisor as the details would vary by concentration). These new courses include Foundations of Federal Indian Policies, Tribal Sovereignty through Self-Determination, and Tribal Economic Development and Diversification. Recent MPA alumni

may also be able to benefit because they may already have taken some courses that are needed for the Graduate Certificate and thus may be able to earn the certificate with an additional 6-9 credit hours. Again, we expect this to be on the books in fall 2023 but still need to complete the curriculum approval process. We look forward to a long and thriving collaboration with the tribes of the Three Fires Confederacy and to serving individuals who work directly for the tribes, related gaming enterprises, and other tribal organizations. This initiative helps promote the SPAA value of enhancing social equity in Southwest Michigan, but this is also just the first step.


