Executive Summary

- FY 2022 Q1 vs FY 2021 Q1
 - Proposal Submissions
 - 27% increase in number of proposal submissions
 - **78% increase** in total proposal value
 - Awards
 - 13% increase in number of awards
 - 32% decrease in value
 - 2 large awards FY 21
 - Total similar to other quarters in FY 21
 - Expenditures
 - **45% increase** in expenditures
 - 2.3% increase in F&A percentage

NOTE: Higher Education Emergency Relief Funding (HEERF) of \$21.8M and Miller Auditorium Shuttered Venue Grant of \$1.8M are excluded from the data and reporting.




Proposal Submissions

Q1 FY 2022 proposal submissions were 27% greater than Q1 FY 2021.


Year-over-Year Comparison

Moving Average of the Total Number of Proposal Submissions




Value of Proposal Submissions

Two large proposal submissions drove Q1 FY 2022 to record setting levels.

- Charles Henderson of the Mallinson Institute submitted a \$15.0M proposal to the National Science Foundation.
- Joseph Kretovics of ELRT put forward a \$14.4M proposal with the U.S. Department of Education.


Year-over-Year Comparison | Total Value of Proposal Submissions | (in Millions \$)

Proposal Sponsors


Federal agencies continue to be the dominant sponsor type.



Q1 FY 2022 awards came in 13% higher than Q1 FY 2021.


Year-over-Year Comparison

The recent averages reflect the impact the pandemic has had on grant awards.


Moving Average of the Total Number of Awards

The value of Q1 FY 2022 is less Q1 FY 2021, which had two substantial awards occur totaling \$9.9M.


Year-over-Year Comparison (in Millions \$)


Two substantial awards occurring in Q1 FY 2021 impact the recent rolling average.

Expenditures

Expenditures in Q1 FY 2022 increased over Q1 FY 2021 by \$2.8M. Q1 FY 2022 Indirect/F&A percentage is currently running 2.3% above the prior year.
