The updated title and course description are reflective of current terms and language used within the field. Modifying the course restrictions for this course, as well as five other courses required for Michigan's central office endorsement, is needed to ensure course restriction consistency.

The core outcomes to be assessed for this course, as part of our CAEP program accreditation, include four Educational Leadership Constituent Council (ELCC) standards: ELCC 2.1 (Candidates understand and can sustain a district culture and instructional program conducive to student learning through collaboration, trust, and a personalized learning environment with high expectations for students); ELLC 2.2 (Candidates understand and can create and evaluate a comprehensive, rigorous and coherent curricular and instructional district program); ELCC 2.4 (Candidates understand and can promote the most effective and appropriate district technologies to support teaching and learning within the district); and ELCC 3.5 (Candidates understand and can ensure that district time focuses on supporting high-quality school instruction and student learning).

Integration of technology in the planning and design of facilities will be addressed as well as the human physiological and psychological needs. Current state and Federal regulations will be reviewed as they relate to new facilities and to remodeling of current facilities.
