## **Reports of Officers**

## Graduate College Office-Lewis Pyenson

Over 100 doctorates will be given by the end of the summer. The Graduate College is facilitating the application for an Integrative Graduate Education Research Training (IGERT) grant through the National Science Foundation. Eleven faculty members from nine departments are working on this grant. The preliminary proposal deadline is 29 March.

Office of the Vice President for Research—Daniel Litynski and Paula Kohler

Fifteen proposals for the Research Development Award have been received and the proposals will be reviewed soon. The committee hopes to have decisions made by 15 April. A display case in the Bernhard Center is being used to increase the visibility of faculty research on campus and it currently features research from Art and Engineering. OVPR is hosting two upcoming workshops: one on grant development for Research Development Award winners as well as other participants and another on preparing budgets for grant proposals (the latter will take place 7 April from noon-1:30 in room 209 of the Bernhard Center). They are coordinating these workshops with Andrea Beach, director of faculty development in Online Education. OVPR will do an electronic survey to better respond to faculty and staff needs and to prioritize future workshop topics.

OVPR is collecting boilerplates from colleges and units to help the entire university more efficiently apply for grants. Boiler plates already received may be found on the OVPR Web site (click on "proposal development tools," then under Pre-award process click on "Boilerplate Language.") Built specifically for OVPR, a database is being created that gives PIs access to bucksheets for each of their grants through the OVPR Web site. Electronic signatures will be available with this new system as well. This new system will allow OVPR to gather data directly from the PIs to make the process more efficient.

# Council Chair—Steven Ziebarth

Eleven Support for Faculty Scholar Awards (SFSA) were submitted and five were funded. Letters will be sent to all the applicants soon. Several RPC members are preparing explanation letters to help those not funded to apply again with better results. Those letters will be finished on Monday, 15 March.
