# **Procedural Items**

#### **New Business**

Discussion of 2014-15 Council Charges

Council Chair - Paul Ciccantell

- Council charges consider criteria for internal funding mechanisms
- criteria doesn't fit
  - a. allocation of funds
  - b. criteria of internal funding
- Support for Faculty Scholar Award (SFSA) dilemma in Faculty Research and Creative Activities Support Fund (FRACASF) process, possibly presenting policy changes - what to do?

Bertman- modify language, tried scoring group. Rubric more useful and relevant.

Doesn't represent change in policy, we can change rubric. SFSA &
Faculty Research and Creative Activities Award (FRACAA) - one
committee to look over both, one group directing the course of action.
Crafting new Memorandum of Action, needs to go to full Senate

**Abudayyeh** - yes - council MOA needs to go back to full Senate to make policy changes.

Changes in rubric- vote here or vote in Senate

**Bertman** - to avoid future confusion, look at actual amounts for allocation.

A motion was made by Bertman, supported by Venter, to accept recommendation by the Office of the Vice President for Research for exact allocation amounts for the Faculty Research and Creative Activities Support Fund. Motion passed

Charges #1 & #7 - modifying charges

**Anderson** - what's the problem?

unanimously.

**Ciccantell** - disenfranchisement in certain areas, does not adequately include all areas

**Solomon** - propose to form committee to look at all aspects of SFSA and FRACAA - common problems seems to be verbiage

**Bertman** - perceived inequities, need more communication Motion - more specific about language of rubric

Stapleton - history of internal funding, years of non-welcoming feeling
Part of the problem is education and understanding the rubric

**Abudayyeh -** Are the workshops effective?

**Bertman** - At Research and Dessert there were 5 to ½ dozen who attended the workshops, if someone has serious issues with their project or funding there are resources available to help

**Wagle -** should we make workshops mandatory? **Solomon -** No

**Solomon -** motion to survey Charges #4, #5, & #7 2<sup>nd</sup> by Osama Abudayyeh

Bertman - #4 and #5 - make procedures more transparent

**Spybrook** - define list, grants to individual that doesn't seek from outside funding sources

Ciccantell - We can define as we see fit
Education Workshops? Do something else? Issues linked between
SESA and ERACASE

**Councell-Vargas** - who's monitoring number of proposals?

Ciccantell- Paula Kohler/OVPR does this

Bertman - #4 - what is the quality of external proposals?

Is FRACASF increasing external funding, is FRACAA working? Disenfranchisement is separate.

Review rubric language of judging - what constitutes external funding

Bertman - is happy to work on language of review criteria

**Abudayyeh** - suggested Paula Kohler to review external funding language

RPC Chair Ciccantell to confirm that Rudge and Kohler were willing to serve on committee 2, since neither were present. Both subsequently agreed to serve.

## Motion passed.

Issues raised and discussed regarding #6 - Research and Creative Activities Day **Abudayyeh** - continue or expand Poster Day?

Brown - people who worked the event were stressed. Issues raised last year, the only people attending the event were graduate students and those working the event. No deans or chairs - need a clearer idea of what is the purpose before inviting businesses. It's difficult recruiting judges. The new format was disappointing to the Creative Arts participants, they did not like having to answer questions. If continue with this format; may not participate.

Councell-Vargas - does not know the history of Poster Day

**Ghantasala** - likes seeing all of the different people from other colleges - gives him a perspective on what's going on within the University

**Stapleton** - the Poster Day committee is comprised of: graduate students, RPC, and Graduate Studies Council

Dean of the Graduate College - Susan Stapleton

This morning discussed at the semester meeting of graduate directors:

- Interdisciplinary doctorate reviewed 30 different universities that have these degree programs (mostly peer and MAC schools) - will be proposing to offer at WMU
- 2) Change language to allow for transfer 1 + 1 masters with international partnership uses up to 16 credit hours if MOA is in place
- 3) Obstacles for regular graduate students for residency process requires receipts through the year. They are contributing to discovery for the University and if they are not in the country or in Michigan, they're not able to get receipts. Working with Patti Van Walbeck, associate vice president for business and finance, to allow the graduate director or advisor to write letter indicating student is off doing research or scholarly work.
- Working on a Research-Toolbox for graduate students with John Risley from OVPR
